Updates on Police Performance Figures;

In the previous four weeks, only a small number of reported crimes;

Firework problems were reduced compared with 2001;

Reviewed the meeting of Community Cllrs at the Police station on 11th October 2002:

Police have written to QMH verge parking offenders. No repeats;

Travelling People have now moved to Kelty;

Wilma Allday raised drinking issues in playpark;

Douglas Campbell raised ideas of boulders to prevent verge mounting. Helen Law would investigate;

Police encourage public to report crimes on Tel: 318700.

8] TREASURERS REPORT:

The Treasurer reported that the balance of the Community Council account stood at around £2300. An accurate report would be provided at the next meeting.

9] COUNCIL:

Balfour Court: Fence completed.

Balfour Court: 3 lamp posts costed into the locality budget at the bottom of the court as it is quite

dark. Should be in place in the next few months.

Robertson Rd: Cracked pavement fixed. Another area still to be fixed.

Farnell Way: A letter explaining the areas of responsibility for owners had been received.

Community Safety: Boozebusters being extended.

Whitefield Road/Halbeath Road: A School crossing patrol is to be located at the junction.

Whitefield Road: Cllr Law has asked the Chair of Planning to take up the issue of the islands and pavement.

Travelling People: Again the arrival of Gypsy/Travelling people has caused distress to some in the area. Lesley Corio who looks after the site at Kelty has been in contact with the group
