MINUTES OF MEETING HELD ON WEDNESDAY 10th September 2003 AT 7.00PM IN THE JAMES ALLAN CENTRE, DUNFERMLINE.

- 1] <u>CHAIRMAN'S OPENING REMARKS & APOLOGIES:</u> Vice-Chairman Tom Brand welcomed everyone to the meeting. Apologies were received from Wilma Allday (Madam Chairman), Kate Findlay (Treasurer), Arthur Ashton, Douglas Campbell, Cllr. Jim Tolson & Dave Manderson.

3] MATTERS ARISING FROM MINUTES:

7] EAST END PARK

Views were sought from members on the issue raised by DAFC about re-instating drinking, within the grounds, during football matches. After much discussion, it was unanimously agreed that this would be a bad idea and the Secretary was instructed to pass on the views to DAFC and the Police.

8] <u>55A</u>

Steve Walker of Stagecoach had given a provisional date for the rerouting of the 55A via Alderston Gardens. Steve Walker would be contacting the Secretary by the 12th September with confirmation of the actual date. The Secretary would then publicise this on the website.

9] COUNCIL:

In the absence of both Councillors, particularly Cllr Wood, most Council Issues could not be updated. They were therefore carried forward to the next meeting. Points that were made included:
