- 1] **Madam Chairman's Welcome / Apologies:** Madam Chairman welcomed everyone to the meeting ... Apologies were received from Tom Brand (Vice Chairman), Graeme Whyte, Douglas Campbell, Cllr. Jim Tolson, Dave Paterson (Fife Council) & M Robertson.
- 2] **Minutes:** The Minutes of the last meeting were read and approved. They were moved by Janet Miller and seconded by Lilah McKay.
- 3] **Matters Arising From Minutes:**
 - 1] Co-op Grounds, Bins at the rear not emptied and strong winds blowing contents all over the neighbourhood, Road sweeper not able to empty bins at front of shop due to bad weather, a visit from Environmental Health has been organised and we await their reply before we act. Fife Council did not empty bins due to bad weather, all dog bins were not emptied either, ask council to install a new bin on Paton St Lane.
 - 2] + point for the Council was the pavements being cleared of snow.
 - 3] Milk bottles dumped in salt bins, we will write to Aitken & Wiseman.
 - 4] Hospital parking still a problem awaiting Bylaws to be adopted to allow action to be taken against the culprits, some correspondence received from NHS discussing additional parking within the Hospital Grounds.
 - 5] Jean Mackie Centre parking by parents at school times causing damage to grass verges.
 - 6] Buses 55 & 55A have improved but the D7 still a problem.
 - 7] Street Lighting on Alderston drive and the lane are on **all the time**, can they possibly be switched off.
- 4] **Madam Chairman's Report:** The chairman had a phone call from the Press asking if we had put in objections about the Lauriston Gardens planned housing Development, Madam Chairman outlined the objections due to the School catchment problems and possible parking issues, plus the issue of selling of prime retail land for affordable housing with no gain to the community: re - a skateboard park, these may be reported in the local Press
