- 1] <u>Madam Chairman's Welcome / Apologies:</u> Madam Chairman welcomed everyone to the meeting ... Apologies were received from Cllr. Jim Tolson and belated apologies were received from Kate for last month.
- **Minutes:** The Minutes of the last meeting were read and approved. They were moved by Douglas Campbell and seconded by Tom Brand.

3] Matters Arising From Minutes:

Parking at Queen Margaret Hospital, Secretary reported an E Mail had been received from Jim Leiper (NHS Fife) that Board approval had been given for funding for 100 additional parking places on the QMH Campus, hopefully these would be in place this financial year. Existing situation not getting any better, still problems with the South access road today with cars parked on both North (12) and South(3) side and also Robertson Road causing a blind spot for drivers egressing Alderston drive. Police stated that enforcement action is still continuing with 12 tickets issued recently.

Colliston Road flooding. Cllr Wood commented Ron Peat (Fife Council) has stated that their may be a legal issue with Smart Homes Madam Chairman stated that Brent Vivian (Fife Council) had not responded to issues raised at previous site meeting on 15 Nov 04.

Play Park on Colliston Road, Cllr Wood flooding issue still a problem

Safety Barriers. Cllr Wood stated that they have been ordered and it is a staffing issue for installation. Other barriers being erected in Dunfermline, possibly we'll be next.

Bus Shelter, Continuing problem, issue with costs as the new shelter has to comply with new legislation (e.g. Lighting).

Robertson Road gardens. Boundary Fencing issue continuing, Police to monitor situation

Whitefield Road Roundabout & Kingseat Road Lining, work already started on lining, roundabout scheduled for 2006.

Kick Pitches, "E" Mail from a resident thanking everyone, favourable discussions took place and we will keep an eye on the situation.

Hectic Life Signage, continuing item for Cllr Tolson.

Traffic Regulations, Football parking restrictions, continuing problem, possible changes to parking in front of East End Park and other parking issues.

Bellyeoman View Estate Open Spaces, discussion on residents' responsibilities. Community Council to letter all Tilbury residents.

Colliston Road Residents Meeting, Community Council to arrange meeting of Residents to organise a residents committee.

CO-OP Bins, Discussion on bins being interfered with during silent hours, secretary to write to the Co-op maintenance department. Also late deliveries of goods, initial planning consent was given for up to 19.00 weekdays & 14.00 on Saturday and no deliveries on Sunday.
