#### 3] Matters Arising From Minutes:

Parking at Queen Margaret Hospital: Is not getting any better and there has been movement on the site, posts have been erected around the copse area to the north side of the bottom road to stop parking. Hopefully they are about to start on the extension to the car park. Derek Moore intimated that the hospital is about to appoint a Transport Officer who will co-ordinate the bus service also investigate car sharing schemes. Car park users are to be identified i.e. Possibly train station users. The hospital is aware of the parking problems and is trying to resolve them. Use of the Robertson Rd. football ground car park has been a problem because of council storage of winter salt for the roads, this has blocked the usage of several parking spaces. Cllr. Tolson stated that planning approval for the car park extension was approved today.

**Bellyeoman View Estate Open Spaces:** After reviewing deeds, it was decided that all residents of both Beldorney Place & Balvaird Place are responsible for the open space maintenance within the Tilbury Development. A letter is to be sent to all residents asking them to form a residents association to appoint a factor to maintain the overgrown areas.

**Colliston Road Open Spaces.**: Discussions took place on this and it was decided to write to Smarts Homes.

**Leys Park Road Car Park.** Cllr Tolson stated that planning approval was passed today despite the many contentious issues, all other alternative possible sites were dismissed.

Coop Bins. Wilma is to write to the Coop Facilities Department to deal with this.

**Laureston Gardens Slope.** Wilma commented on both slopes, Dave Paterson is waiting on a reply, he stated that there will have to be contract in place for ground maintenance by Kingdom Housing.
