- 8] **Police Report:** This was taken out of order to allow PC Cree to leave early due to operational commitments; He introduced himself to the meeting stating that PC Miller and himself will be working together, he reported several incidents to be aware of:
Minor Vandalism and more worrying was Sneak Thefts, due to the warm weather people leaving windows & doors open. Some cars have been broken into.
Knife amnesty is ongoing and a depository is available at the Main Police Station.
Alcohol test purchase to be allowed by 16-17 year olds, 900 premises to be tested over 12 months, current hot spots are known Fife Council ready to act. CC questions resulted in, Blue Light Disco, no date been set. Vans parking at the top of Townhill Road causing congestion, Whitefield Road roundabout road markings and speed limit are a cause for concern.
