Issues raised included...

- School Catchment review seems to have 9 options for the way forward with only 2 suitable to the Board, awaiting Fife Education decision.
- Lynebank extension, patients being transferred from Carstairs there has been a change of risk level of these patients
- Lauder /Donald St. rubbish, Cllr Wood has this in hand.
- Whitefield Road roundabout still ongoing.
- Estates Department have proposed that the new Street off Alderston Drive be named Larach View, apparently this name has been derived from an Alliance of 6 Housing Associations, this is not what the local community would like, they suggest Alderston Court.
- Crossing on Robertson Road, nothing to report.
- 3rdParty rite of appeal, Kate & Wilma attended a meeting in the City Chambers and this appeal status should be kept. Also local gain to the Community, namely Playparks etc. They could maybe be better advised as to what the community needs, youth facilities, community halls etc.
- Needles, concerns at 34 Haig Cres. Dave Paterson was to give details of who to contact for their uplift? People take shortcuts through gardens and dumping needles. This will be investigated on boundary fences etc. Photographic evidence available.
