8] Police Report

Points from Previous minutes

1. Retaining Wall at Coop damaged on 21st March, this appears to be further damage already reported to the Coop Facilities Department.
2. New Houses on Alderston Drive, contractors to reinstate the verges, contractors to park on the road not on verges. BT duct cover damaged, not properly protected.
