MINUTES OF MEETING HELD ON WEDNESDAY 11th Jun 2008 AT 7.00PM IN THE JEAN MACKIE CENTRE, DUNFERMLINE.

- 1] **Madam Chairman's Welcome / Apologies:** Madam Chairman welcomed everyone to the meeting ... Apologies were received from Kate Findlay (Treasurer), Douglas Campbell, Dave Paterson (Fife Council) and Graeme Whyte. It was agreed to take the Police report first to allow PC Ferguson back to duty, also to listen to 2 delegations before the main agenda.
- 8] **Police Report:** 8 Crimes in the past month, 7 detected, 1 undetected was an Awning from the back garden in Christie St. theft attended. Please keep items of value out of site in cars, also keep back doors locked. QMH 22 parking tickets issued in the month. Wilma stated that Hospital staff parking in Station Car Park, station complaining. Good news for all residents, a Closure Order on Leny Place, tenants not returning. Lorimar Gardens, no site of any children, bottles or stones on road, Police to monitor. Townhill Road Co-op double yellow lines, difficult to police also vans on pavement.

FIRST DELEGATION: School Football Scheme, David O'Donnell and his Football Team gave a presentation on the need in our area for an All Weather Football Pitch (Presentation added to Correspondence), this would be for the whole Community, also asked for funding through the school for Ready-Net inflatable Goals, probable costs of £179 with a 5% reduction if bought via school, to be considered.

SECOND DELEGATION : Post Office Closures, Wilma introduced Angela Russell from Transy Post Office, Couston St. she gave a presentation on all the people and businesses who use this service. This is scheduled for closure and was asking for support from the Community Council which we totally support. This follows the closure of Townhill Rd & Reid St. Public meeting organised for 7:00 pm in the Vine Church, Garvock on 23rd June. At present the PO is open 51¹/₂hrs / wk., could be more if required. Leaflets were available for doorstep delivery, these will be distributed locally.

- 2] **Minutes:** After consideration it was agreed to give £179 for the Ready-Net goals. The Minutes of the last meeting were read and approved as amended. They were moved by Jessie Cartmell and seconded by Derek Moore.
