DRAFT MINUTES OF MEETING HELD ON WEDNESDAY 12th NOV 2008 AT 7.00PM IN THE JEAN MACKIE CENTRE, DUNFERMLINE.

PRESENT:

- 1] **Madam Chairman's Welcome / Apologies:** Derek Moore (Vice Chairman) took the Chair in the absence of Wilma, he welcomed everyone to the meeting and apologies were received from Wilma Allday (Madam Chairman),
- 2] **Minutes:** The Minutes of the last meeting were read and approved. They were moved by Douglas Campbell and seconded by Jessie Cartmell.
- 3] **Matters Arising From Minutes:**
 - QMH parking issues:-** Cllr McCulloch stated the Travel Plan does not appear to be working, General discussions on Traffic Management, parking of staff in QMF, residents concerns about access problems, Local Police aware of situation, possible yellow lines, possible one way system to be adopted in Hospital grounds, Cllr McCulloch in discussions with Fife Council – NHS making some inroads.
 - Leys Park Road Car Park:-** Cllr McCulloch stated that the car park is still to be used for the Tesco Development of the Thomson Furniture Warehouse site and Cllr Burke stated the shuttle bus will be reinstated.
 - Sinclair Gardens Roundabout:-** Problems at mini roundabout at Gardener St., problems with phasing of lights and crossing lights, Discussion on Fife Council Yard Vans Ongoing.
 - Kingdom Developments High Slope:-** Ongoing
 - Playpark Drainage:-** Ongoing, Dave Paterson
 - Barriers and steps, Paton Street :-** Site visit proposed, not taken place, Derek to speak to Dave Paterson.
 - Pedestrian Crossing, Robertson Road :-** Sited at shops awaiting start, planned for Dec 2008?.
 - Crushing Plant & Concrete Plant:-** Planning permission refused, keep a lookout in case they appeal.
- 8] **Police Report:- (Taken early to allow PC back to duty)**

PC Lawrie Ferguson provided accident stats for Sinclair Gardens Roundabout, not as bad as had been thought, Traffic flow improved. 32 Recorded crimes, only a few of note, Mobile Phone theft, have details of a Suspect, Driver on Robertson Road, Assault of a 15 year old girl on bonfire night, Police looking for 2 youths one with a Pink & White Hoody the other with a Pink & Grey McKenzie Hoody. Car Parking in QMF Police advice is to phone in to complain for all occasions.
- 3] **Matters Arising From Minutes: Continued**
 - QMF Enforcement Action and Open Spaces:-** A petition put into Cllr McCulloch, 98% of residents want enforcement action on Thistle Homes, general discussions took place on how long these issues have been ongoing, also there is insufficient lighting in 2 areas, incomplete by Thistle homes, possible danger to the public.
 - Viewpoint Improvements;-** Kate sent in a form to Dave Paterson, no reply yet. Ongoing
 - Ground to the North of the School:-** Dave Paterson still investigating.
 - Path in park opposite Church:-** Cllr McCulloch Stated that Transportation have been in discussions with Ron Peat about this and **Lighting at recycling area.**
 - Grit bin location in QMF:-** Cllr McCulloch to look into this + an extra bin at hammerhead,
 - Proposals for funds:-** Meeting no date set yet.
 - Drainage in Cemetery:-** Still very bad Dave Paterson to investigate.
