- **Madam Chairman's Welcome / Apologies:** Madam Chairman welcomed everyone to the meeting ... Apologies were received from Cllr Jim Burke & Steven Miller (Community Police Officer).
- 8] Police Report, taken early to allow the officer back to duty.

Inspector Downie has left, his replacement is Insp. Ian Patterson on the Community Team. Also Sgt Ian Flynn is moving, to be replaced by Sgt Andy Smith, also on the Community Team.

There have been 37 crimes in this area, with 23 detected, this will increase. Good prevention work needed.

Alcohol Test Purchasing—intelligence led, 6 Premises tested, 2 Failed first attempt but passed second. Cllr Mogg concerned about this type of testing. Not an entrapment issue.

Dome-Hawk Camera (mobile CCTV) sighted in Townhill. Police also have a handheld camera for ASBO's this is now in use.

Cllr Mogg reported that access has been gained to the Thistle Homes Compound at QMF, can something be done to make this site safe??? A discussion took place concerning this site and Safety Concerns, Police to investigate what action can be taken.

2] <u>Minutes:</u> The Minutes of the last meeting were read and approved with a minor amendment. They were moved by Douglas Campbell and seconded by Kate Findlay.

3] Matters Arising From Minutes:

Bus Station Problems:- Cllr Mogg stated that these problems are the subject of a legal dispute between the Council and Developers.

QMH:- Cllr McCulloch stated ,Lesley King Fife Council Transportation Officer is having a meeting with QMH transport committee with a follow on Meeting with Councillors. Funding issues discussed. Derek attended a meeting about the Travel Plan, also problems with Traffic Warden Jurisdiction.

Leys Park Road Car Park: - Some repairs carried out.

Sinclair Gardens Roundabout:- Ongoing problems with Light Fazing issues, also with road markings.

Kingdom Developments High Slope:- Problems with Bulb planting, Ongoing.

Playpark Drainage: Contractors mess after New Nursery Build.

Barriers and Steps, Paton Street: - Ongoing.

Pedestrian Crossing, Robertson Road :-. When will it be commissioned?

Crushing Plant & Concrete Plant:- Planning appeal Documentation received, awaiting a decision.

Viewpoint Improvements: - Ongoing awaiting Dave Paterson.

Ground to North of School :- Pathway Design & Build in place, Cost implications and adoption issues.

Pathway in Park (next to New Nursery):- Ongoing including Lighting at recycling area. Project funding required by March, Contractors mess an issue.

Proposals for Funds :- Wilma & Graeme to arrange Newsletter

Drainage in Cemetery:- Ongoing

Doggy Bins in Park:- Not been replaced yet Cllr McCulloch to investigate.

Street Lighting: - No 2 Light in Lane from Alderston Drive to COOP not working for up to 6 months.

Robertson Road tree Roots:- This is becoming a problem again.

Bellyeoman Road Pot Holes:- Temporary repair carried out.

Coop Verge Damage :- Ruts caused by both Delivery Drivers & Council vehicles. This is also a major Problem in the Public Park caused by Council vehicles.
