MINUTES OF MEETING HELD ON WEDNESDAY 10th MAR 2010 AT 7.00PM IN THE JEAN MACKIE CENTRE, DUNFERMLINE.

PRESENT:

Wilma Allday (Madam Chairman), Derek Moore (Vice Chairman), John Dudgeon (Secretary), Kate Findlay (Treasurer), Jessie Cartmell, Douglas Campbell, Cllr David Mogg, Cllr William McCulloch, Cllr Jim Burke & PC Mark Thompson (Community Police Officer). A member of the public was Graeme Whyte.

- 1] **Madam Chairman's Welcome / Apologies:** Madam Chairman welcomed everyone to the meeting. No apologies were received.

- 8] **Police Report** This had been removed from the agenda as no police report was expected. PC Mark Thompson apologised for not providing a report for the last meeting and stated that a report would be provided. There had been 23 crimes in the area mostly in QMH, 12 detected 11 not. Discussions took place on the Community Engagement Meetings (Townhill CC) with no involvement from Bellyeoman residents, Police to provide posters to try to get some response for the next meeting to take place on 5th May. Reports that dog bins had been set on Fire, also lots of broken bottles, Reports that a gang of youths were in the area, Police were aware and would continue to be a presence in the area. - 2] **Minutes:** The Minutes of the last meeting were read and approved. They were moved by Douglas Campbell and seconded by Graeme Whyte.

- 3] **Matters Arising From Minutes:**
 - Bus Station Problems :-** Snagging issues, Ongoing.
 - QMH & Robertson Road Parking:-** New proposals for yellow lines and parking bays were discussed. A general discussion on Hospital problems and also problems with the future of the Hospital Pharmacy, Derek to E Mail Cllr Mogg. Ongoing.
 - Leys Park Road Car Park:-** Derek made a statement of the issues. Council are to cover retrospective Planning Permission, Cllr McCulloch to raise issues. Could we please get a neighbourly amicable resolution to the lighting problem Cllr Mogg to investigate, possible local solution Ongoing.
 - Sinclair Gardens Roundabout :-** Light phasing for traffic from Townhill Road is still a major issue at peak times, Site meeting still to be organised, Ongoing.
 - Ground to North of School:-** Due to start 22nd March 2010. Ongoing
 - Pathway in Park (next to New Nursery) including Lighting at recycling area:-** 2010/11 project. Ongoing.
 - Bellyeoman Road Pot Holes :-** Speed bump notices are a menace, too far onto the road. Bollards not in place, Cllr McCulloch stated the contract was not completed yet. Ongoing.
 - Coop Verge Damage :-** 2010/11 project. Ongoing.
 - Buses :-** Wilma unhappy again, she has spoken to Stagecoach for reasons but was unsatisfied with their answer, The local Stagecoach Manager is to action.
 - New Row Parking :-** Cllr Mogg stated that the issue will be resolved when the work on East Port is complete. Wilma stated that pedestrians were not accommodated for during the works. Pedestrians causing traffic problems at the top of New Row can the pedestrian crossing be relocated to the bottom of Bonnar Street, Cllr Burke to check if crossing can be moved, Cllr Mogg to check with Cllr for Central Dunfermline
 - New Museum :-** Ongoing with favourable results with lottery funding.
 - Bin Emptying:-** New bins to be supplied within 2 years..
 - Cemetery Drains :-** Still very bad, Cllr McCulloch to investigate.
 - Dave Paterson's (Fife Council rep) replacement:-** Not in place yet, interviews possibly next week.
 - Parking in Turning Circle, Beldorney Place. :-** Problems with council vehicles turning, Cllr Burke has reported this to Leslie King (Fife Council).
