MINUTES OF MEETING HELD ON WEDNESDAY 11 FEB 2015 AT 7.00PM IN THE JEAN MACKIE CENTRE, DUNFERMLINE.

- 1] **Madam Chairman's Welcome / Apologies:** Madam Chairman welcomed everyone to the meeting, Apologies were received from Jessie Cartmell.
- 2] **Minutes:** The Minutes of the last meeting were read and approved with amendments. They were moved by Ken Barker and seconded by Wilma Allday.
- 3] **Matters Arising From Minutes:**
Bellyeoman Road speed signs: This matter is still ongoing going to ask Phil Clarke when he comes to a future meeting.: on-going
New Row Parking: - Proposed TUCAN crossing to be installed, Alhambra area. on-going.

Item 8 Police Report taken next. Crime statistics for the area are as follows:-

Car damaged at QMH, 2 shoplifting offences at Coop, 1 shed break in at Dick Street, 1 undetected Gas Meter theft at Adamson Crescent, 3 Domestic, 1 sex offence, 1 wilful Fire Raising, 1 Stop & Search - £150 worth of cannabis found.

Also Operation Facet for traffic offences, 1 mobile phone and seat belt offences detected.

The Community Team is now made up of 3 teams of 2 officers and the new meetings will be arranged with the change of venue to Jean Mackie Centre (JMC).

Items raised by Community Council:

Parking at Coop on Townhill Road, the speed of traffic and parking on Double Yellow Lines (DYL), as the DYL are now decriminalised the police don't police them but they can look at the overall problem and take action.

Parking at JMC is to be looked at as well and also the school to be informed.

Dog Warden the police can contact them but you can do it yourself. Problems with dogs off the lead and causing an ex Community Councillor to be knocked down on lane from Townhill to Whitefield Road, reported to councillors and Courier.

End of Police Report continue with Meeting.

New Row Parking: - The problems are at the top of the New Row with Two crossings within three car lengths these should be controlled by lights or removed and resited, it is pedestrians that control the flow of traffic on East Port. Problems with parking on DYL also Taxis parking out with the rank.

Whitefield Road Stop line: It was noted that when the stop lines were renewed before Christmas, the inside lane stop line was returned to its former position after our lengthy campaign to have it moved back a few yards to aid the sightline of the Stop signal for motorists waiting to turn left onto Halbeath Road, to contact Cllr Law.

Alderston/Beldorney Common Areas: this issue is still outstanding with no action from Fife Council. Cllr Campbell is still pursuing possible solutions including Council Enforcement Liability. - on-going.

General Parking Issues: It was agreed that these matters should be held for a future attendance by Phil Clarke of Fife Council.

Robertson Road Post Box and Telephone access box:- The poor condition of the verges is not improved: – on-going

Queen Margaret Fauld Blue Sheds: Cllr Campbell has still to contact James Thomson (Solicitors) about this matter. – on-going

Dog Fouling: Cllr Law spoke to the dog wardens, situation not improved:- on-going
