- 2] **Police Report**
Area 2B from 08/03/17 to 08/04/17. Bellyeoman & Townhill. There was 110 call cards resulting in 17 crimes, 13 detected and 4 undetected, some with further enquiry required, also area 2A, Headwell, 31 crimes, 20 detected, 11 undetected.
