- 3] **Minutes:** The Minutes of the last meeting were read and approved with amendments. They were moved by Keith Omond and seconded by Wilma Allday.

  - a) **Chairman's Report**

  - b) **Secretary's Report Inc. Correspondence:**

The following correspondence was reported and made available to the meeting by the Secretary. The saga of the Planters and Benches continues, only 2 Benches in position and bolted down, the 3<sup>rd</sup> Bench had to be reordered, only 5 Planters ordered. The £1201 we were due to give Fife Council for Planters, Benches and summer planting and compost, the money included £400 for compost and summer planting is not required this can be used to buy the extra Bench and Planter with £38 left, a voucher for said amount was received and purchased 11 bags of compost, currently stored at home awaiting planters to be positioned. No other correspondence.

- 6] **Ongoing Issues**
  - a) **Taylor Wimpey Applications**, Gordon Harvey stated they had made two applications one for 1400 houses across North Halbeath, and one for 340 houses at Whitefield Rd. about 90 objections so far including BCC. The public require to be able to identify the site, which is a fundamental requirement of legislation. They have identified a new route for the NRR, old records have identified mine workings on the Route.
  - b) **Paton St. Update**, BCC put an article in the Press in early July, Alistair Hamilton responded with an Email on the 19<sup>th</sup> July and that is the last we heard from the Council. Wilma was not happy at the way things have gone, they said they have answered all our questions which they have not. Sylvia has stated there is a wet garden problem in Kingseat Road properties caused by bad drainage issues? Mr Whyte stated that all issues with fences and gabions have changed and drainage issues still a problem. Cllr Law stated we should get somebody along to the next meeting to explain the situation.
